#### **OFFICIAL MEETING MINUTES**

Monday, November 10, 2025

1:00 PM - 2:30 PM (Arizona Time)

Location: Professional Fire Fighters of Arizona Office, 61 E. Columbus Ave., Phoenix, AZ / via Zoom

#### 1. Call to Order

The meeting of the Arizona Fallen Firefighters Memorial Committee was called to order at 1:00 PM by Chair Dan Freiberg. A quorum was present.

Present: Dan Freiberg (Chair), David Breeckner, Thomas Torres, Gordy Cunningham joined, Timothy Tait, Mike Colletto, and Chief Jake Rhoades.

Also present: Crystal McCracken, Administrative Assistant. Ben Norris Attorney General's Office/legal advisor.

# 2. Welcoming Remarks

Chair Freiberg opened the meeting and welcomed attendees. Ben Norris announced his retirement effective at the end of 2025.

# 4. Review of Statutory Authorities Responsibilities

Ben Norris summarized the Committee's duties under A.R.S. §41-1861 through 1863 and under A.R.S. §41-1808, including setting memorial standards, determining eligibility for inclusion, maintaining the memorial, and conducting the annual ceremony. The Committee is required to meet biannually in January and May, with additional meetings permitted.

The Committee discussed inconsistencies regarding when names are added to the wall. Members proposed adopting a fiscal year cycle (July 1–June 30) to determine eligibility for the following January ceremony. Ben Norris confirmed this is authorized under A.R.S. §41-1862(A)(1)–(2). Chair Freiberg directed that development of a standards and timeline policy be added to the next agenda.

David Breeckner suggested scheduling a third meeting each year between June and January to finalize eligibility. The Committee agreed this would aid in logistics and family communications.

The Committee discussed improving public access. David Breeckner volunteered to contact the Arizona State Library to correct the broken link to AZFirefighterMemorial.com. Crystal McCracken confirmed that the current website remains active and compliant.

# 5. Tuition Waiver Scholarship Review

The Committee reviewed the tuition waiver application for Hudson Yule, son of Scottsdale Firefighter Corey Yule, for attendance at Arizona State University in Fall 2026.
