1. Call to Order

The meeting of the Arizona Fallen Firefighters Memorial Committee was called to order at 1:00 PM by Chair Dan Freiberg. A quorum was present.

5. Development of Memorial Standards and Criteria

The Committee discussed the development of formal standards and criteria for inclusion on the Arizona Fallen Firefighter Memorial Wall.

Gordy Cunningham explained that recognition by the International Association of Fire Fighters (IAFF) Fallen Fire Fighter Memorial in Colorado Springs, Colorado, and/or the National Fallen Firefighters Memorial in Emmitsburg, Maryland, serves as a qualifying factor for verification and consideration for inclusion on the Arizona Fallen Firefighter Memorial Wall.

The Committee discussed inconsistencies regarding when names are added to the memorial wall. Members proposed adopting a fiscal year cycle (July 1 through June 30) to determine eligibility for recognition at the following January Arizona Fallen Firefighter Memorial Ceremony. Ben Norris confirmed this is authorized under A.R.S. § 41-1862(A)(1)–(2).

Committee members agreed that, if the need arises, a third meeting may be scheduled each year to finalize eligibility determinations prior to the annual memorial ceremony.

Committee members discussed the importance of creating a consistent process that can be applied fairly and uniformly in future years.

No action was taken.

6. 2025 Arizona Fallen Firefighter Memorial

The Committee discussed planning for the Arizona Fallen Firefighter Memorial Ceremony scheduled for Sunday, January 11, 2026.

Gordy Cunningham encouraged Committee members to attend the Arizona Fallen Firefighter Memorial Ceremony on January 11, 2026. Mr. Cunningham advised that the ceremony would begin at 10:00 a.m. and would last approximately one-half hours.

Committee members acknowledged the efforts of the memorial volunteers and staff who work throughout the year to honor Arizona's fallen firefighters and preserve their legacy.
